Participant, for himself/herself and on behalf of his/her dependents, heirs, administrators, executors and assigns, hereby releases, discharges and agrees to hold harmless the College and its trustees, agents, employees, representatives and volunteers from and against any and all liability, including liability for negligence, arising out of or in any way connected to Participant's participation in the Program. For purposes of this Release, "liability" means all claims, demands, losses, causes of action, suits or judgments of any kind that Participant or Student's heirs, executors, administrators and assigns may have against the College, and any of its trustees, agents, employees, representatives and volunteers because of personal injury, accident, illness or death, or because of any loss or damage to property that occurs to any person, including Participant or his or her property, during the Program, and that results from any cause including, but not limited to, the College or its trustees', agents', employees', representatives' or volunteers' own negligence.
